The total cost of a 2-hour pool party rental is **\$250.00**. This includes a **non-refundable deposit of \$50.00 to secure your booking date and is due within 2 weeks of booking your party**. There is an additional \$25.00 fee for parties greater than 60 individuals. Events exceeding 60 individuals must be approved at the time of booking. A final headcount must be provided to The Shack Neighborhood House, Inc. three (3) days before the event. **The remaining balance is due the day of the event.** Unpaid balances will be subject to event cancellation.

All checks are to be made payable to **Shack Neighborhood House Inc.** When using a check for payment, you agree to the following terms: *In the event your check is dishonored or returned for any reason, you authorize The Shack Neighborhood House Inc. to electronically (or by paper draft) re-present the check to the bank account for collection of the check amount, plus any applicable fees as permitted by state law.*

The Shack Neighborhood House Inc. reserves the right to cancel any group scheduled to use the facility for any reason. Ordinarily, notice will be given to the group at least 24 hours prior to the scheduled event. Events cancelled by The Shack Neighborhood House Inc. due to staffing issues, inclement weather, or declaration of state of emergency will receive a full refund if the event cannot be rescheduled.

The undersigned personally and individually on the behalf of the applicant accepts liability for all repairs to the facility and/or repair or replacement of any equipment in the event of damage.

In the event that you and/or your guest are unable to adhere to the above stated guidelines, you will be charged additional rental fee and/or asked to vacate the premises by the facility staff and/or the police department. By signing below, the applicant acknowledges that he/she is responsible for ensuring that all guests adhere to the above rules and will provide payment for the use of the facility by the assigned date.

POOL RULES, POLICIES, & PROCEDURES

- Parties are only allowed to use the POOL AREA, DECK, & SHOWER ROOMS. All other areas are closed to guests.
- Children must be supervised at all times. Children are not permitted to enter rooms not contracted by the rental agreement.
- NO ALCOHOL of any kind is permitted on or in The Shack Neighborhood House Inc. property.
- SMOKING IS NOT PERMITTED ANYWHERE INSIDE THE POOL OR DECK AREA.
- Doors will remain locked until 15 mins prior to rental time. Please do not arrive earlier than your rental time.
- RUNNING ON POOL DECK IS PROHIBITED
- It is the renter's responsibility to remove all decorations and tape before leaving.
- All items that have been brought in by the renter must be removed from the facility by the end of the rental time. The Shack Neighborhood House Inc. is not responsible for any items left at the facility. Items for function cannot be stored overnight.
- NO PETS, service animals only.
